The Meeker County Ag Society reserves the right to cancel this event at any time or this contract without cause. The Meeker Ag Society cannot be held responsible for the acts of Mother Nature which have a negative effect of the event.

**Wednesday** – Entry day and people are hungry so you could be open 10:00 am – 2:00 pm

**Thursday** – Tractor Pull in Grandstand - generally ends around 10:00 pm

**Friday** – Concert in Grandstand – music goes until midnight

**Saturday** – Derby in Grandstand - generally ends around 8:00-9:00 pm

**Sunday** – Motocross in Grandstand starts at 2:00 pm and ends around 6:00 pm.

Food vendors are required to be open by 10 am and stay open Till 10 pm. Vendors can choose to be open earlier or later if they wish.
